I. By signing this «Statement of Accession», the Learner confirms that they:

1) Are fully familiarized with and accept the terms of the Agreement, placed on the official website of the University on the Internet <https://qairu.kz/> and in accordance with the Civil Code of the Republic of Kazakhstan give their irrevocable consent to accede to it;

2) Subject to compliance with the regulatory acts of the Republic of Kazakhstan, internal documents and procedures of the University, give their unconditional and irrevocable consent to be enrolled into the body of Learners of the University:

II. The introduction of amendments and additions to the Agreement, to the cost of educational services for the respective academic year, is carried out on the terms determined in the Agreement and is subject to mandatory publication on the website of the University on the Internet <https://qairu.kz/> ;

IV. The Agreement enters into force from the moment of signing this Statement, under the following conditions:

1) payment for tuition by transferring the total amount to the settlement account of the University as a lump sum before August 25 of the current academic year or payment of 40% of the specified annual cost no later than August 25 of the current academic year;

2) provision to the admissions committee of the University of the full list of documents determined by the Admission Rules to the University.

V. Tuition payment for subsequent periods:

30% of the specified annual cost before the beginning of the examination session of the first trimester of the current academic year;

30% of the specified annual cost before the beginning of the examination session of the second trimester of the current academic year.

VI. In the event the Learner, studying under an internal grant or having received a discount (except for a social discount and a discount granted to students from regions affected by floods) for tuition, is dismissed from the University on any grounds, such Learner shall be obliged to reimburse the cost of tuition for the entire completed period at the prices of the academic credit for the respective academic periods.

VII. The Agreement may be terminated by the Learner by submitting an application to withdraw this Statement of Accession, subject to the conditions stipulated by the Agreement, the issuance of a corresponding order on dismissal, or non-inclusion in the enrollment order to the body of learners.

The conclusion of a Termination Agreement in this case is not required.
